The vehicles are available for viewing at the Hopkins County Schools Central Office, 320 South Seminary Street, Madisonville, Kentucky 42431. Contact George Jones (270)825-6050 for an appointment to view the vehicles. The central office is open from 8:00 A.M. through 4:00 P.M. on weekdays only. The viewing dates are May 7, 2019 through May 15, 2019.

The public bid opening is set for 8:00am May 15, 2019 at the Hopkins County Board of Education Office at 320 South Seminary St. Madisonville, Kentucky 42431. All bids must be submitted on or before that time. No bids will be received and read after that date and time. The buyer must have proof of legal transfer before removing any vehicle from the premises of the Hopkins County Schools. The successful bidder(s) will be notified within (7) seven business days of the bid opening. Payment is to be made by cash, certified check, cashier's check or money order made payable to the Hopkins County Board of Education within 30 days of Board approval.

The bid must be sealed and clearly marked with the designation "**Surplus Vehicle Bid**". The bid must be signed by a member of the company(or by an individual) who is authorized to sign the bid document. All bids will be good for a period of thirty days from the bid opening.
